Why are we here today?

Eastcroft incinerator is highly polluting releasing a cocktail of poisons including heavy metals, PCB's and dioxins, which we know can cause cancer.

The Environment Agency is failing in its duty to protect the residents of Nottingham from this cancer factory.

We demand that the EA carries out its duty and issues an enforcement notice to ensure that Eastcroft fully complies with its IPC licence all of the time and if it cannot comply, the EA takes steps to close it down!

Eastcroft's Record – The Facts Speak for Themselves

- 2002 Twelve self-reported unauthorised pollution breaches.
- 2003 Four self-reported unauthorised pollution breaches.
- 2004 Seven self-reported unauthorised pollution breaches.
- 2005 Four self-reported pollution breaches.

Despite the fact that Eastcroft emits a cocktail of hundreds of toxic poisons, the EA specifies that only a handful are constantly monitored. Yet the most toxic and cancer causing, are spot checked only twice a year, and independently checked by the Environment ONCE a year!

In March 2005, dioxins released into the atmosphere for the residents of Nottingham to consume, were found to be 900% of their allowable level.

What action did the EA take with this major breach of the most cancerous chemical known to science. They wrote a letter to Waste Recycling Group, telling them off! NO enforcement notice was issued, NO restrictions, NO prosecution, WRG continue to operate, pollute and profit.
